Subject: 100 years – Together towards a Global Strategic Alignment for an Integrated Security Architecture

The ICPO-INTERPOL General Assembly, meeting in Vienna, Austria, from 28 November to 1 December 2023, at its 91st session:

RECALLING INTERPOL General Assembly Resolution GA-2017-86-RES-06 “Taking a stance on global security”, adopted by INTERPOL’s General Assembly at its 86th session held in Beijing, China in 2017, which supported the seven Global Policing Goals as presented in Report GA-2017-86-REP-07, namely to counter the threat of terrorism; promote border integrity worldwide; protect vulnerable communities; secure cyberspace for people and businesses; promote global integrity; curb illicit markets; and support environmental security and sustainability,

RECOGNIZING the nexus between global security and sustainable development, as outlined in the preliminary analysis conducted by the INTERPOL General Secretariat in 2020 on the links between the seven Global Policing Goals and the 17 United Nations Sustainable Development Goals, and the important role of the Global Policing Goals as a potential means for member countries to meet their commitments under the United Nations 2030 Agenda for Sustainable Development,

MINDFUL of the opportunity presented by the 2023 United Nations review of the implementation of the 17 United Nations Sustainable Development Goals to conduct a review of the seven Global Policing Goals with the objective of assessing them against today’s global threat landscape, as well as to reinforce their alignment with the United Nations Sustainable Development Agenda,

RECALLING ALSO the 2022 INTERPOL Heads of NCBs Conference Conclusion No. 2 “*Ensuring consistency in the international exchange of criminal police data*”, which noted the increasing number of regional platforms and initiatives for police data sharing launched in recent years, and the operational risks of having incongruent or incomplete sets of data made available to countries on the different regional and global databases to which they have access, with the risk of creating inaccuracies,

RECALLING FURTHER the Recommendations adopted by the four 2023 ICPO-INTERPOL Regional Conferences on “Enhancing security co-operation through the 2023 review of the Global Policing Goals and multilateral efforts towards realizing the vision of a global model for a police data-sharing architecture”, which stated that the Global Policing Goals and general principles of a future global model of police data architecture are tools to ensure strategic and operational coordination and alignment between INTERPOL and the regional policing organizations,

ACKNOWLEDGING INTERPOL's initiative "Dialogue on an Effective Multilateral Policing Architecture against Global Threats" (The Dialogue) in creating and maintaining a multilateral framework to engage all regional policing organizations in a continuous and collective high-level discussion to enhance strategic and operational coordination,

WELCOMES the role played by the multilateral platform of The Dialogue in creating the framework for conducting, with the contribution of the regional policing organizations, (1) a comprehensive review of the Global Policing Goals, and (2) a mapping analysis of the current approach to police data sharing, and the common goals and application of the general principles for a future global model of police data sharing;

ENDORSES the outcomes of the 2023 comprehensive review of the Global Policing Goals – including the revised Global Policing Goals and their Sub-Goals and the cross-cutting themes of the Global Policing Goals – as well as the outcomes of the mapping analysis of the current approach to global police data sharing – including the goals and principles of police data sharing – as outlined in the Report GA-2023-91-REP-21.
