COUNTER-TERRORISM GLOBAL STRATEGY 2022-2025

The Global Counter-Terrorism Strategy outlines INTERPOL's plan to support its 195 member countries in combating terrorism in line with INTERPOL's Strategic Framework for the period 2022 to 2025.

MANDATE

"Enable the global law enforcement community to more effectively counter persistent and emerging forms of terrorism through international police cooperation"

OBJECTIVE 1:

Disrupt terrorist activities through enhanced exchange of police data and information on individuals involved in persistent and emerging forms of terrorism.

OBJECTIVE 2:

Improve member countries' awareness of the terrorist threat and its evolution through the provision of actionable and timely criminal intelligence analysis.

OBJECTIVE 3:

Mitigate the terrorist threat by providing member countries with technical expertise, based on a collaborative multi-agency approach, in the prevention, response and investigation of terrorist incidents.

OBJECTIVE 4:

Represent the interests and needs of the global law enforcement community and advocate for the necessary action and dialogue to effectively combat the terrorist threat.

EXPECTED OUTCOMES OF THE OBJECTIVES

OBJECTIVE 1

- Generation of data specifically on individuals associated with terrorism and their transborder movements to support national law enforcement action.
- Increased focus on regional police cooperation across investigative, operational and analytical policing needs.
- Increased use of INTERPOL tools, platforms and expertise where law enforcement agencies and partners can share information, knowledge and experiences on countering terrorism.

OBJECTIVE 2

- Heightened understanding among INTERPOL member countries of the evolving terrorist threat, including emerging and persistent trends, at a regional and global level.
- Sustained focus on stimulating police data sharing in order to continually produce a more complete assessment of the global terrorist threat.
- Prioritized investigative activities by national law enforcement agencies, informed by criminal intelligence analysis.
- Implementation of proactive counter-terrorism measures at the regional and international level, informed by criminal intelligence analysis.

OBJECTIVE 3

- Identification and disruption of terrorist activities through well trained law enforcement officers and well executed law enforcement action, including operational and investigative activities.
- Enhanced focus on benchmarking law enforcement capabilities to address particular terrorist crime types in an effort to build targeted capacity.
- Establishment of baseline understandings of law enforcement needs to counter terrorism through structured, specialized assessments.

OBJECTIVE 4

- Enhanced INTERPOL presence at multilateral and regional fora, with a focus on understanding, communicating and advocating for law enforcement objectives informed by the Membership.
- Increased focus on strategic law enforcement priorities to counter evolving terrorist threats.
- Stronger cooperative framework at the national, regional, and international level on combating terrorist threats, including tailored solutions and initiatives for combating specific terrorist crime types.
