Small Private Online Courses (SPOCs)

INTERPOL offers Small Private Online Courses (SPOCs) on its learning platform, providing learners with smaller, more personalized classes compared to traditional Massive Open Online Courses (MOOCs).

Self-paced eLearning

INTERPOL offers self-paced eLearning on its learning platform, providing individuals with the flexibility to progress through educational materials at their own pace and convenience.

Unlike traditional classroom settings or instructor-led online courses, INTERPOL's self-paced eLearning allows learners to study and complete assignments or modules independently, without the constraints of a fixed schedule or real-time interaction with an instructor or peers.

Learners have the freedom to choose when and where to study, pause, rewind, or fastforward through content as needed, making it adaptable to various learning styles and preferences.

Self-paced eLearning often utilizes digital resources such as videos, interactive quizzes and readings to facilitate learning and assessment.

Webinars

Webinars are online seminars or workshops that allow participants to engage with content, presenters, and other attendees in real-time over the internet. These sessions are typically interactive, with opportunities for participants to ask questions, share insights, and participate in discussions.

Biometric Data and International Data Sharing (BioSPOC)

INTERPOL / Biometrics

Small Private Online Course

Length: 4 weeks

This dynamic and interactive Small Group Private Online Course (SPOC) provides participants with the skills and knowledge required to exchange high-quality biometric data internationally, including through INTERPOL's biometric databases. This SPOC explores DNA profiles, facial recognition images, and fingerprints, and examines the key role of biometrics in solving transnational crimes.

Delivered entirely online through the INTERPOL Virtual Academy, this course requires 3-4 hours of dedicated time per week. Through the specialized learning platform, participants can watch instructional videos, complete modules at their own pace, and exchange ideas through discussion forums with international colleagues and instructors. Weekly webinars offer participants an additional opportunity to interact and ask questions directly to INTERPOL's biometrics expert panels.

Fundamentals of Open-Source Investigations (FOSI)

Professional Policing Competencies / OSINT

Small Private Online Course

Length: 6 weeks

Over the past decade, internet consumption has grown rapidly around the world, resulting in the widespread use of the Internet and social media by criminals and terrorists. This poses many challenges for law enforcement officers as the use of the online space by these actors has created new and far-reaching virtual areas that need to be monitored, investigated, and countered by police. INTERPOL recognizes that law enforcement should be given every opportunity to harness the Internet and social media to support their investigations, regardless of the crime type or whether they work at HQ or in frontline locations.

Gender and Transnational Crime (Gender SPOC)

Professional Policing Competencies / Gender Mainstreaming in LEA

Small Private Online Course

Length: 4 weeks

Transnational crime, security, and the rule of law are all connected to gender. Gender often impacts how individuals are targeted and recruited by criminals and can affect the roles they play in transnational criminal organizations. Having more gender-balanced teams and working with a gender perspective also improves the effectiveness of law enforcement in combating crime. In this course, learners will explore theoretical concepts and the international legal and policy framework relevant to working with a gender perspective in law enforcement. They will study practical examples of working with a gender perspective in various policing areas and how it can improve operational results, investigating the impact of gender on crime and law enforcement. Participants will focus on areas relevant to their daily jobs and utilize tools and resources that can aid them as law enforcement officers. They will also gain an understanding of the tools and services offered by INTERPOL and how gender considerations can be integrated into their use.

E-Evidence Programme for Prosecutors (EEPP)

Professional Policing Competencies

Small Private Online Course

Length: 4 weeks

The Foundations of e-Evidence course aims to provide the fundamentals of digital evidence and digital forensics from a prosecutorial perspective. Participants will learn techniques for handling real cases involving computer and mobile forensics in various jurisdictions. Over a three-week online period, the course will cover e-evidence in various cybercrime investigations.

The INTERPOL Policing Capabilities Programme (IPCP) stands as a premier training initiative, embodying INTERPOL's commitment to fostering international police collaboration and fortifying global crime-fighting proficiencies. This course is meticulously designed to empower law enforcement professionals with the acumen and competencies necessary for the proficient employment of INTERPOL's suite of tools and services, thereby enhancing their capabilities in preventing and probing transnational criminal activities.

IPCP encompasses a thorough exploration of INTERPOL's four Global Programmes, the legal framework, the principles governing data management, access to pivotal databases, and the practical application of data processing tools. Furthermore, it elucidates the array of products available for bolstering international police cooperation and the intricacies of the INTERPOL Information System.

I-24/7 General Introduction (EN-2-055)

Number of modules: 2

Certificate: Yes

Languages: English, French, Spanish, Russian, Arabic

The course covers a general introduction to I-24/7, databases available on this global communications system, different connection methods for National Law Enforcement Agencies, and security aspects for the safe implementation and operation of the I-24/7 system.

Crime Scene Investigation e-learning Course (EN-2-889)

Professional Policing Competencies / Crime Scene Management

Length: 2.35 h

Number of modules: 7

Certificate: Yes

Languages: English, French, Portuguese, Arabic

Six modules cover the following topics: Biological Evidence, Crime Scene Documentation, Crime Scene Management, Crime Scene Photography, Fingerprints, and Processing and Packaging Physical Evidence.

Risk Communication in a Biological Incident (EN-2-951)

Crime Areas / Counter Terrorism / CBRNE

Number of modules: 6

Certificate: Yes

Languages: English, French

This course is designed to explain the concept of risk perception, address the challenges of risk communication across different types of biological incidents, describe the basic principles of risk communication, outline the main principles of rumor management, and discuss strategies for utilizing community resources to enhance risk communication efforts.

INTERPOL DNA Database and International DNA Data Exchange (EN-2-202)

Number of modules: 1

Certificate: No

Languages: English, French

The objective of this course is to define the characteristics of the INTERPOL DNA Database, identify the quality and format requirements for the international exchange of DNA profiles, and list the various transmission options for the international exchange of DNA profiles.

The Automated Fingerprints Identification System - AFIS (EN-2-919)

The purpose of this course is to help learners define the legal framework for biometric data transmission through the IP channels, identify the INTERPOL security features for biometric data transmission, apply the operational procedure to transmit biometric data through the INTERPOL channels, and apply the necessary protocol to use the AFIS gateway.

Gender Mainstreaming in Law Enforcement (EN-2-803)

Professional Policing Competencies / Gender Mainstreaming in LEA

This e-learning course will address the following points: the concepts that underpin the work on gender (gender, gender equality, gender responsiveness, gender mainstreaming), the key international instruments relevant for gender equality and women, peace, and security issues, how gender-responsive policing services support better provision of law enforcement outcomes, and what can be done to promote gender equality and women's empowerment in law enforcement.

I-24/7 Security (EN-2-004)

Provides a detailed description of the security features of the I-24/7 system, including the purpose and functionalities of the system, operational procedures, gateways, and resources.

Locate, arrest and extradite persons wanted at international level (EN-2-061)

This course aims to outline the cooperation between states in seeking, arresting, and extraditing suspected or convicted criminals, which is central to INTERPOL's role.

This course aims to outline the mutual legal assistance procedure, particularly in the exchange of police information, and to present INTERPOL's role in this cooperation procedure.

The aim of this course is to provide an outline description of the international criminal courts and to present INTERPOL's cooperation with them.

This module is divided into five parts aimed at providing a general understanding of the following topics: the United Nations Security Council mandate, cooperation between INTERPOL and the United Nations, particularly between INTERPOL and specific Security Council Sanctions committees, and practical examples of implementing UNSC sanctions regimes through expert testimonies. It also explains the purposes and process of the INTERPOL-UNSC Special Notice, an INTERPOL tool created to enforce UNSC sanctions regimes by circulating relevant information related to entities and individuals subject to UNSC sanctions to an extended law enforcement network.

e-ASF2: INTERPOL Databases Courses (EN-1-029)

HOTSPOT Field Deployment e-learning Course (EN-2-968)

This course serves as an introduction and explanation of the HOTSPOT Project Field Deployment. The HOTSPOT project aims to support beneficiary countries in their fight against foreign terrorist fighters (FTFs) and their affiliates, who may attempt to manipulate the flow of irregular migrants entering their territory illegally. The project involves collecting biometrics from individuals directly at the spot, primarily in reception centers for foreigners, and cross-checking this data against INTERPOL databases online.

The purpose of the I-link Portal is to streamline all INTERPOL database tools available on its secure I-24/7 Network. The portal centralizes tools for exchanging and recording information (I-link Forms) and querying data stored in INTERPOL databases (search engine, eASF2). Additional resources are also available for user reference. Access to I-link requires an I-24/7 connection.

FROST - Field Risk Online Security Training (EN-2-044)

This course will help INTERPOL officials gain awareness of the types of risks they may encounter during missions abroad and provide them with practical response elements if an incident threatening their security occurs.

Cultural Adjustment (EN-1-033)

Cross-functional Skills / Personal Development

Certificate: No

Languages: English

The aim of this tutorial is to: 1) Help new expatriates and local staff understand the psychological process newcomers from overseas go through after settling in a new country and manage it better, and 2) Sensitize new expatriates and local staff to apply INTERPOL values and core competencies, such as respect and effective communication, to cultural adjustment in order to interact smoothly and tactfully.

Strengthening Border Management in West Africa (EN-2-925)

Crime Areas / Border Management

Through practical guidelines, tips, and techniques, this training assists officers working in border environments in better identifying and intercepting illicit goods or persons at border crossings, while ensuring that legitimate goods and travelers can pass without unnecessary impediments.

E-Mail Investigations (EN 2-929)

Crime Areas / Cyber & Cyber-enabled crime / Digital Forensics

The goal of this course is to demonstrate how email communications are carried out and how they can be traced to their source by examining extended metadata. Additionally, anti-forensic techniques that can be employed to avoid the traceability of emails will be discussed. By the end of the course, participants will be able to summarize the operation of email, differentiate between different types of email, demonstrate the use of email headers, understand the concept of anonymity, and discuss issues regarding traceability.

Financial Investigations related to the Forest Sector (EN-2-934)

Crime Areas / Organized & Emerging Crime / Environmental Crime

Number of modules: 1

Certificate: No

Languages: English, French, Spanish

Participants will enhance their skills in investigating financial crimes, specifically money laundering, related to the forest sector. By the end of the course, participants will be able to: define money laundering according to FATF standards from memory, list three channels of international cooperation available for investigating money laundering as mentioned during the instruction, outline how the international trade system is misused to launder criminal proceeds according to FATF publications on trade-based money laundering, and describe the difference between shell and shelf companies according to international standards concerning beneficial ownership.

Dark Web Investigation Fundamentals (EN-2-926)

The aim of this course is to teach users the basics of Darknet investigation, addressing the need for law enforcement officers to better understand and investigate the Darknet effectively. After completing this course, you will be able to: identify the two methods of accessing the Dark Web, learn how TOR works according to the TOR Project, and acquire three investigation and searching techniques for Dark Web information.

INTERPOL Security Document Examination (EN-2-927)

This scenario-based e-learning course aims to support members of Law Enforcement Agencies in identifying fraudulent documents. The course provides valuable tips and strengthens users' abilities to detect fraudulent documents. It consists of one module and includes pre-training and post-training questionnaires.

Watermarks in Security Documents (EN-2-946)

In this course, you will learn how watermarks are produced and the optimal method for examining them. The course will demonstrate how genuine and imitation watermarks appear under different light sources.

Machine Readable Zone in Security Documents (EN-2-948)

This course explains the characteristics of the Machine Readable Zone (MRZ) found in passports, visas, and ID cards. It covers the appearance of the MRZ, including the number of characteristics, the relationship between the variable information in the visual inspection zone and the MRZ, and the overall shape and height of the characters in an MRZ.

Open Source Intelligence in investigations (EN-2-932)

Professional Policing Competencies / Open-Source Investigations

Languages: English, Spanish

The learning objective of the course is to explain what Open Source Intelligence (OSINT) is and to demonstrate some OSINT techniques, as well as to help identify some OSINT tools.

E-course on Counter-Terrorism Investigations in Online Terrorism Cases (EN-2-788)

Crime Areas / Counter Terrorism / Terrorist Networks

Number of modules: 1

Certificate: No

Languages: English

The objective of the course is to support national efforts to counter and prevent the Foreign Terrorist Fighter (FTF) phenomenon by sharing good practices with law enforcement officials on how to use the Internet and social media for counter-terrorism investigations. The course is divided into three sections: The evolving threat and use of the Internet, including social media, for terrorist purposes; Good practices in conducting online investigations for counter-terrorism purposes; and Steps for requesting the preservation and collection of electronic evidence, including from service providers.

Radiological & Nuclear Terrorism (EN-2-922)

Crime Areas / Counter Terrorism / CBRNE

The course is divided into 5 modules covering various aspects of radiological and nuclear terrorism, including radiation basics, risks and threats, detection methods, trafficking, incident prevention, preparedness, response, and media management. Primarily intended for law enforcement and other entities involved in preparedness and response to criminal and terrorist attacks involving nuclear and radioactive materials, it is also valuable for external auditors seeking to increase their awareness and preparedness in case of incidents.

Bioterrorism Incident Pre-Planning and Response e-learning Course (EN-2-944)

This course is designed for law enforcement officers and stakeholders from various sectors who may contribute to bioterrorism preparedness and response efforts. It outlines basic concepts, best practices, techniques, and procedures related to bioterrorism prevention and response.

Cyber Crime Fighting - Course (EN-2-003)

This course is a video training program on Cyber Crime Fighting titled 'The Law Enforcement Officer's Guide to Fighting Online and Computer Crime.' The course is divided into 13 chapters, each featuring a training video followed by a highlights section. Topics covered include types of internet crimes, digital evidence, seizing computer equipment, examining and storing digital evidence, obtaining information from Internet service providers, and tracing internet suspects.

Identifying and Seizing Digital Evidence Course (EN-2-086)

The project aims to strengthen countries' ability to combat cybercrime and collaborate regionally and internationally.

The goal of this module is to recognize the importance of securing the online work environment before conducting online investigations. The learning objectives of this course are as follows: After completing this module, participants will be able to:

Identify possible individual and organizational risks resulting from not securing the online working environment prior to conducting an investigation.

Summarize the four main points of vulnerability that can compromise online security.

Suggest at least five ways to properly create a more secure online working environment.

Exercise good judgment and discretion with personal information shared on social media.

Introduction to Digital Forensics (EN-2-930)

The goal of this course is to demonstrate how to plan and conduct a search and seizure operation at a high-tech crime scene. Additionally, it discusses the principles for the seizure of electronic evidence, various anti-forensic techniques employed by suspects, and the importance of live data forensics in relation to volatile memory.

Darknet Course - CEPOL & INTERPOL (EN-2-947)



EVENT DESCRIPTION

Webinar held on 23 November 2022

Organized by INTERPOL Cybercrime Directorate and delivered by experts from Kaspersky, which is a private-sector partner of INTERPOL.

The cyber criminal community has evolved, not only from a technical point of view but from the standpoint of their organization. Today hacker groups (also known as threat actors) have a complex

structure similar to legitimate organizations with their websites\blogs, codes of ethics and areas of operations. They are also a source of the most discussible incidents nowadays. They are groups of high skilled guys with the same motivation – earning money. Based on the analysis of hundreds Darknet platforms and posts published for the recent 2 years, this webinar describes the entire chain on how they get money:

- (1) Hiring a team members and making a group (salaries, bonuses and responsibilities);
- (2) Purchase of data on Darknet markets to prepare an attack (initial access, drops, etc.);
- (3) Selling a stolen data and money laundering.

The research shows extensive coverage of activities coming from high motivated and skilled cybercriminal groups on the Darknet forums and platforms. Nowadays Darknet is a multi-functional

resource which is used by cybercriminal as a recruitment platform, market for any illegal data (including access to the victim companies) and also social networking service with hacker groups' blog

where they promote their activities. Research results and our broad analysis of these different Darknet functions will demonstrate the practical importance of Darknet monitoring which helps to see trends

on cybercriminal activities, detect information on new attack victims and proactively react on it, track of new data leakages. Large enterprises and SMBs should consider using threat intelligence data which

will also cover such data sources and provide same insights to build the comprehensive picture of threat landscape.

3) Ransomware Today webinar
