Former Palmeiras Coach and Six Others Charged with Match-Fixing in Football

Coach Estevam Soares and six others have been charged by the Superior Court of Sports Justice (STJD) for involvement in a match-fixing scheme during last year's Série D of the Campeonato Brasileiro, with the prosecution seeking penalties at both national and international levels under FIFA's Disciplinary Code.

China

Investigations into Chinese chess 'Recording Gate' scandal revealed, 3 grandmasters banned for life

The Chinese Xiangqi Association (CXA) has penalized 41 players who were banned for life and stripped of their titles for match-fixing and bribery that harmed the sport's integrity. Investigations into the "Recording Gate" scandal revealed widespread corruption, leading to suspensions, reprimands, and ongoing probes into unethical conduct within the Chinese chess community.

Sevilla defender Kike Salas under investigation over yellow cards

In Spain, Sevilla defender Kike Salas has been arrested and remains under investigation for allegedly receiving yellow cards deliberately to benefit friends who placed bets, reportedly earning around €10,000. If found guilty, Salas could face a prison sentence, fines, and a multi-year ban from football, while Sevilla and La Liga emphasize their commitment to the legal process and anti-match-fixing measures.

The chairman of the Hong Kong Football Association, acknowledged that legalizing football gambling could provide resources for the sport but stressed the need for caution and community consideration, given the potential societal impact. While emphasizing a zero-tolerance stance on match-fixing, Fok highlighted efforts to combat corruption, including a Fifa-recognized monitoring system, and pledged to support the growth and integrity of Hong Kong football.

Amid match-fixing probe, Dara maintains a clean record

Cambodian goalkeeper, Vireak Dara, has excelled in the Cambodian Premier League with 10 clean sheets this season, but faced allegations of match-fixing after costly errors in Cambodia's 2-1 loss to Singapore in the ASEAN Mitsubishi Cup. The Football Federation of Cambodia has launched an investigation into the accusations, though no findings have been released, while Dara remains benched for national team matches.

Sportradar Reports Notable Decline in Match-Fixing in 2024

In 2024, global sports saw a 17% decline in suspicious matches, with Sportradar Integrity Services identifying 1,108 suspicious events across 70 sports, including notable reductions in soccer and Brazilian football. Despite the progress, Sportradar emphasizes the need for continued vigilance, innovation, and collaboration to combat persistent match-fixing and safeguard sports integrity worldwide.

Investigation concluded as ex-RFEF President faces corruption charges

Former RFEF President Angel Maria Villar is facing charges of fraud and corruption for favoring his son, Gorka Villar, in business dealings during his tenure, which led to the RFEF being defrauded out of €4.5m. This investigation is part of a wider scandal that has tainted the Royal Spanish Football Federation, following the removal of Luis Rubiales and ongoing controversies surrounding his successors.
