For the prevention and suppression against transnational organized crime become more deepened and efficient, we recommend that INTERPOL need to have close and flexible mechanisms of action in order to support Police force of member countries to improve the effectiveness of combating crime; continue to improve the mechanism of bilateral and multilateral cooperation in fighting against transnational organized crime, especially in investigation and extradition; regularly organize international and regional forums to share information about modus operandi, exchange experiences, as well as propose measures to detect, prevent and fight effectively against crime; strengthen cooperation in the areas of training, retraining law enforcement officer, timely support facilities and technical equipment; continue to consider of participating and nationalizing of international treaties on the crime prevention and suppression in order to narrow the gap in the laws between countries, create a adequate legal framework for the crime prevention and suppression.

Ladies and Gentlemen,

Government and people of Vietnam always perform consistently the foreign affairs policy of independence, self-reliance, peace, cooperation and development; multilateralised and diversified relations, proactive and active international integration, contributing to the protection of peace, national independence, democracy and social progress in the region and around the world.
