<u>Subject</u>: Authorization for car manufacturers to access relevant data from the INTERPOL Stolen Motor Vehicles database – Project INVEX (Phase II)

The ICPO-INTERPOL General Assembly, meeting in Dubai, United Arab Emirates, from 18 to 21 November 2018, at its 87th session:

RECALLING its Resolution AGN-64-RES-04 on Stolen Motor Vehicles, and Resolution AG-2009-RES-09 on Cooperation with car manufacturers for the purpose of combating the traffic in stolen motor vehicles (Project INVEX),

NOTING WITH SATISFACTION the successful implementation of Project INVEX pursuant to Resolution AG-2009-RES-09, and the effective cooperation with the car manufacturers in Germany,

RECOGNIZING the ongoing contribution of the INVEX Working Group of INTERPOL member countries in preparation for Phase II of Project INVEX, and welcoming its initiatives to extend the cooperation with car manufacturers incorporated in other member countries,

REAFFIRMING the value of the support provided by the car manufacturers in improving the quality of INTERPOL's Stolen Motor Vehicles Database and enhancing its capabilities to detect stolen motor vehicles and components,

BEARING IN MIND the provisions of Article 28 of INTERPOL's Rules on the Processing of Data (RPD), which foresee exchange of data with and processing of data by private entities under agreements to be concluded with INTERPOL,

HAVING CONSIDERED Report GA-2018-87-REP-10 of the General Secretariat, which sets out the proposed cooperation in the framework of Phase II of Project INVEX, including the proposed General Conditions for Cooperation with Car Manufacturers in the Framework of Project INVEX ("the General Conditions") in Appendix 1, based on which agreements may be concluded with selected car manufacturers in application of Article 28 of the RPD,

CONVINCED that sharing of information on stolen motor vehicles and components with selected car manufacturers can enhance the quality of the data recorded in the SMV database and facilitate international law enforcement cooperation in combating organized crime,

APPROVES the cooperation proposed in Report GA-2018-87-REP-10 for Phase II of Project INVEX, and authorizes direct access by the selected car manufacturers to the stolen motor vehicles data made available by the member countries for the Project, in accordance with the conditions specified in Article 28 of the RPD;

APPROVES, in accordance with Article 28(3) of the RPD, the General Conditions, based on which agreements shall be concluded with the selected car manufacturers;

AUTHORIZES the Secretary General to make the necessary arrangements to implement Project INVEX II and conclude agreements with the selected car manufacturers on the basis of the General Conditions;

URGES member countries to enhance cooperation in combating trafficking in stolen motor vehicles, *inter alia*, by populating the SMV database and ensuring the accuracy of the data provided.
