# ORGANIZED AND EMERGING CRIME GLOBAL STRATEGY 2022-2025

The Organized and Emerging Crime Strategy outlines INTERPOL's plan to support its 195 member countries in tackling serious transnational crime in line with INTERPOL's Strategic Framework for the period 2022 to 2025.

## MANDATE

*"Support member countries in reducing the impact of serious, organized and emerging crime, thereby protecting societies and vulnerable communities, for a safer world."*

### OBJECTIVE 1:

Reduce the impact of serious, organized and emerging crime through enhanced law enforcement information exchange.

### OBJECTIVE 2:

Enrich actionable intelligence products by crosschecking information and analysing data sets on serious, organized and emerging crime.

### OBJECTIVE 3:

Support countries' investigations and develop their ability to prevent and respond to transnational serious, organized and emerging crime through operational support and capacity building.

### OBJECTIVE 4:

Optimize INTERPOL's support to the global law enforcement community to tackle transnational serious, organized and emerging crime through forging and fostering synergies, sharing resources and knowledge, and strengthening partnerships.

## EXPECTED OUTCOMES OF THE OBJECTIVES

### OBJECTIVE 1

- Development and fostering of cooperation mechanisms between specialized agencies and National Central Bureaus to maximize the collection and exchange of relevant and high-quality information on organized crime groups.
- Help to address information gaps to support member countries' investigations.
- INTERPOL to serve as a central repository and act as the global gateway for the transmission of information relating to organized and emerging crime.

### OBJECTIVE 2

- Improvement in the intelligence picture to develop an in-depth understanding of the organized crime threat landscape for the benefit of member countries.
- Enhanced processes to crosscheck, analyse and disseminate timely and relevant information for the proactive development of actionable intelligence on organized crime.
- Development of high-quality intelligence, assessments, and analytical products to effectively support and bring added value to the purposes and actions of INTERPOL member countries.

### OBJECTIVE 3

- Improvement in the impact and quality of investigations for the benefit of member countries.
- Enhanced development of tailored operational activities to support member countries' investigations or to enable them to build their own capacities to prevent and respond to organized crime.
- Increased real-life and real-time capacity-building opportunities for member countries to learn methodologies and techniques, acquire skills and reinforce their competences.

### OBJECTIVE 4

- Strengthened cooperation and partnerships with relevant regional and international partners and the wider global law enforcement community and the judiciary, including those working within the field of victim support assistance and civil society.
- Establishment of new synergies with actors from the public and private sector whose information, skills and expertise can usefully contribute to supporting member countries' investigations.
- Strengthening INTERPOL's leadership in the global security architecture and in the global fight against organized crime.
