



## Resolution No. 3

GA-2024-92-RES-03

**Subject:** Connecting a global community of analysts to bolster data sharing and the analysis of evolving transnational crime threats, criminal networks and their business models

The ICPO-INTERPOL General Assembly, meeting in Glasgow, United Kingdom, from 4 to 7 November 2024, at its 92nd session:

CONSIDERING that timely and accurate crime analysis is crucial for both operational and strategic police planning and action,

RECOGNIZING that analysis, particularly the swift production of quality, threat-driven crime analysis, is a strategic priority for INTERPOL,

APPLAUDING the work to produce the biennial INTERPOL Global Crime Threat Assessment and continuous efforts to map and assess high-threat transnational organized crime groups, notably their transregional and transcontinental impact, from the Organization's unique global perspective,

SUPPORTING the initiative of the Criminal Analysis Sub-Directorate to create the INTERPOL Global Analysis and Intelligence Network (I-GAIN) to connect a global analytical community of analysts from member countries and partner organizations,

ALSO RECOGNIZING the importance of the development of the INSIGHT platform to enhance the analytical capabilities of INTERPOL and the successful implementation of its new capabilities,

FURTHER RECOGNIZING the central role of the Crime Analysis Files (CAFs) and the value for member countries in joining and regularly contributing relevant data,

ACKNOWLEDGING the pioneering work undertaken by Project ENACT to build analytical capacity in member countries in Africa, notably among women police officers, through the establishment of analytical units as well as the womENACTion and related initiatives, which encourage gender mainstreaming in analysis and law enforcement in Africa,

CALLS UPON member countries to join I-GAIN by providing the Criminal Analysis Sub-Directorate with an appropriate analytical point of contact and actively engaging through this collaborative network, by sharing intelligence and analytical findings;

URGES member countries to provide meaningful responses to requests for information from INTERPOL's specialized crime units, notably through the Global Crime Threat Questionnaires, which are fundamental to building an accurate global crime threat assessment;

FURTHER ENCOURAGES member countries to regularly contribute relevant data to all INTERPOL databases, and to participate in and populate the relevant INTERPOL CAFs;

REQUESTS member countries to support the secondment of qualified officials to the General Secretariat to fill vacancies for criminal intelligence analysts, for both operational and strategic analytical work, as well as data experts to reinforce the analytical workforce of the Organization;

ALSO ENCOURAGES member countries to turn to INTERPOL for analytical support, notably benefiting from new analytical capabilities through INSIGHT and to clean, cross-check, and analyse complex data collected in the context of ongoing, transnational investigations.
