Subject: Report of the Working Group to Review Legal Provisions Relating to INTERPOL's Governance Bodies – Amendments to the Organization's General Regulations and Rules of Procedure of the General Assembly pertaining to the ad hoc Committee

The ICPO-INTERPOL General Assembly, meeting in Glasgow, United Kingdom, from 4 to 7 November 2024 at its 92nd session:

PURSUANT to Article 44 of the Organization's Constitution and Articles 45(4) and 65(1) of the Rules of Procedure of the General Assembly,

BEARING IN MIND Resolution GA-2018-87-RES-15, adopted by the General Assembly at its 87th session (Dubai, United Arab Emirates, 18-21 November 2018), establishing the Working Group to Review Legal Provisions Relating to INTERPOL's Governance Bodies ("Working Group on Governance"), and Resolution GA-2023-91-RES-04, adopted by the General Assembly at its 91st session (Vienna, Austria, 28 November – 1 December 2023), tasking the Working Group on Governance to review the mandates of the General Assembly's committees, notably the Regional Conferences, the Committee on the Processing of Data, and the Working Group on Governance,

HAVING CONSIDERED Report GA-2024-92-REP-02 submitted by the Working Group on Governance, containing the Working Group's proposed reform pertaining to abolishing the ad hoc Committee, and its mandate being taken over by other committees of the General Assembly, including the Committee on Governance and the Committee on the Processing of Data,

RECALLING that the ad hoc Committee has traditionally limited its examination to the procedural formalities on the proposed modifications of the General Regulations and their Appendices and the Constitution,

RECALLING ALSO the mandates of the General Assembly consultative bodies, including the Committee on Governance and the Committee on the Processing of Data,

EMPHASIZING the conclusions of the 11th meeting of the Working Group on Governance (Lyon, France, 6-7 May 2024), in particular the need to avoid overlaps between the mandates of the General Assembly consultative bodies and the crucial need for continued review of the legal texts of the Organization,

HAVING NOTED the opinion of the ad hoc Committee, set up in application of Article 56 of the Organization's General Regulations,

APPROVES all of the amendments to the relevant provisions of the General Regulations and the Rules of Procedure of the General Assembly, as set out in Appendix 1 of Report GA-2024-92-REP-02;

DECIDES that the aforementioned amendments shall enter into force immediately, following the close of the 92nd session of the General Assembly;

EXPRESSES its appreciation to the ad hoc Committees of previous years for their commitment and for the work accomplished;

FURTHER TASKS the General Secretariat to make the necessary arrangements to facilitate the work of the General Assembly consultative bodies and assist them in discharging their mandates.
