Australia

Match called off as police probe alleged approaches to players

In Australia, police are investigating allegations that players from former A-League club Gold Coast United were approached by representatives of a Chinese company to manipulate betting outcomes, leading to the abrupt cancellation of a National Premier Leagues Queensland match. Football Australia and Sport Integrity Australia have reported the matter to authorities, with players reportedly rejecting the advances, while the investigation continues amid a broader crackdown on match-fixing in Australian football.

The Scourge of 'Spot-Fixing' Is Coming for American Sports

In the U.S., Cleveland Guardians pitcher Luis Ortiz is under investigation by Major League Baseball for suspicious betting activity linked to seemingly minor pitch outcomes, raising alarms about "spot-fixing" — a subtle form of match manipulation involving small, discrete events rather than entire game results. This case highlights a growing concern in American sports, as spot-fixing, which has long plagued global sports.

Two Mexican Officials Suspended for Match-Fixing in Costa Rica

The Costa Rican Football Federation suspended two Mexican officials from Asociación Deportiva Municipal Turrialba after an investigation revealed they attempted to bribe players to deliberately lose a match, but the players resisted, underscoring the federation's commitment to combatting corruption and preserving fair play.

ITIA

Two tennis players suspended for failure to co-operate with investigation, CAS dismisses Ferrero appeal

The International Tennis Integrity Agency (ITIA) has sanctioned three tennis players—Uzbekistan's Rakhimbek Ibrakhimov, Croatia's Lauro Milanovic, and Argentina's Melina Ferrero—for breaching the Tennis Anti-Corruption Program, resulting in suspensions ranging from 21 months to eight years and fines up to \$15,000. The violations include failure to cooperate with investigations, betting on matches, and multiple historical corruption offenses, with all three players barred from participating in any ITIA-sanctioned events during their suspension periods.

Nigeria

NFF Nullifies NIo Sanctions, Demands Deeper Probe Into Match-Fixing Claims

The Nigeria Football Federation Disciplinary Committee overturned several Nationwide League One sanctions due to insufficient evidence and procedural errors, notably setting aside Campos FC's two-year suspension and fine over match-fixing allegations pending further investigation. The committee also reinstated match results for Franceex United FC and partially reversed penalties against Cynosure FC and Positive Football Academy.

New Zealand

How fallen A-League star admitted his role in shameful betting scandal - 'earn a little bit of coin'

In New Zealand, former A-League players Clayton Lewis and Kearyn Baccus pleaded guilty to deliberately earning yellow cards to manipulate betting outcomes during matches in 2023 and 2024, receiving \$10,000 each for their involvement in a scheme that generated over \$200,000 in suspicious bets.

Philippines

Korean nabbed in Manila for illegal online gambling

Korean national Lee Yong Jae, wanted for operating illegal online gambling platforms targeting Korean and Filipino users, was arrested in Malate, Manila by the Bureau of Immigration's Fugitive Search Unit in coordination with Korean authorities. Lee, considered a high-value fugitive and public safety threat, is also facing drug-related charges in the Philippines and has been linked to illicit operations generating over 215 billion (PHP9 billion).
