FFC investigate match-fixing speculation over Cambodia's match in Singapore

Cambodia's Football Federation has launched an investigation into potential match-fixing following allegations against goalkeeper Vireak Dara, who made two costly errors during Cambodia's 2-1 loss to Singapore in the ASEAN Mitsubishi Electric Cup 2024. While some fans suspect Dara's mistakes were intentional, his teammates have defended him, asserting that errors are common in football.

Sri Lanka

Lanka T10 team owner arrested on match-fixing charges

In Sri Lanka, the owner of the Galle Marvels was arrested on match-fixing charges by Sri Lanka Police under the 2019 Prevention of Offences Relating to Sports Act, after a foreign player flagged his involvement in fixing. This arrest marks the second instance of a team owner being detained for match-fixing in Sri Lanka's franchise cricket leagues this year.

Ukraine

Journalist on the searches in the match-fixing case: "The current referee of the first league is on the lists..."

Ukrainian journalist Volodymyr Zverov, reported that a current First League referee is among those suspected in a match-fixing investigation, with authorities confiscating phones and gadgets to uncover more information. The case, which also involves esports, traces connections to previous match-fixing investigations in 2018, including the involvement of a suspected organizer.

Sweden

Sweden takes action to combat the manipulation of sports competitions and protect integrity in sports

Sweden ratified the Macolin Convention, strengthening its fight against match-fixing through enhanced international cooperation and becoming the 13th country to adopt this legally binding framework. Swedish officials emphasized the importance of this step in combating cross-border manipulation in sports and ensuring integrity in the gambling market.

China jails ex-football head coach for bribery
