#### Man arrested over attempted bribery of league of Ireland footballer

In Ireland, a man in his 30s has been arrested in connection with an attempted bribery involving a League of Ireland footballer, who reported the incident to Gardaí earlier this season. Although the man has been released without charge, Gardaí are preparing a file for the Director of Public Prosecutions and continue to seek information on match-fixing and sports corruption through a confidential reporting line.

#### Guatemala

#### Court of Arbitration for Sport partially upholds Guatemalan tennis player's appeal

The Court of Arbitration for Sport (CAS) has reduced Guatemalan tennis player Christopher Díaz Figueroa's sanction from a lifetime ban to a six-year suspension and lowered his fine from \$75,000 to \$20,000 due to nine breaches of the Tennis Anti-Corruption Program.

#### **Pakistan**

#### Pakistan Cricket Board banned from signing betting sponsorships after court ruling

The Pakistan Cricket Board (PCB) is now prohibited from signing sponsorship deals with betting companies following a ruling by the Peshawar High Court, which highlighted concerns over gambling brands promoting betting to young people through cricket sponsorships.

#### Sri Lanka

### Sri Lanka spinner Jayawickrama banned from cricket for corruption

The ICC has banned 26-year-old Sri Lankan spinner Praveen Jayawickrama for one year, with the final six months suspended, after he admitted to breaching the anti-corruption code by failing to report a match-fixing approach during the 2021 Sri Lanka Premier League.

#### Uzbekistan

#### Court of Arbitration for Sport dismisses Sanjar Fayziev's anti-corruption appeal

The Court of Arbitration for Sport (CAS) upheld a three-and-a-half-year suspension (with six months suspended) for Uzbek tennis player Sanjar Fayziev, imposed due to five breaches of the Tennis Anti-Corruption Program in 2018. His ineligibility, which began on July 25, 2023, prohibits him from participating in or attending any events sanctioned by tennis governing bodies until July 24, 2026.

#### **United States**

Man pleads guilty in betting scheme that ensnared ex-NBA player Jontay Porter

Gambler Long Phi Pham pleaded guilty to conspiring to commit wire fraud in a sports betting scheme that led to NBA player Jontay Porter's lifetime ban. Pham and three others planned to profit by betting on Porter to underperform, with Porter intentionally benching himself in two games, though the scheme unraveled when a betting company detected suspicious activity.
